


# Background

- Formerly, Yolobus operated Route 217 and provided a lifeline service between Dunnigan, Zamora, Yolo, and Woodland. However, due to the COVID-19 pandemic, Route 217 was suspended in March 2020 and subsequently discontinued in 2021.
- Starting in 2024, YoloTD staff began their outreach efforts with public stakeholders in Yolo. The first objective was to educate the community on the nature of BeeLine, and secondly, to collect feedback regarding the optimal locations for BeeLine stops.



## Yolo Outreach

- On February 20<sup>th</sup>, YoloTD staff discussed BeeLine with Yolo community members and stakeholders during the Eat Well food drive in Yolo, which had 106 attendees.
- On February 21<sup>st</sup>, YoloTD presented to Communicare staff (a non-profit healthcare organization in Yolo County) to provide an overview of ongoing projects (YATC and BeeLine).





## Impact of Yolo Expansion on Existing Knights Landing Service

# Challenges: Challenges:

• Potential impacts to Rider experience in that both travel times and wait times can increase for both Yolo and Knights Landing Riders.

#### **Next Steps:**

- If approved by the Board, Yolo service will begin July 1, 2024
- Staff will continue to monitor trends, update the Board and propose operational changes once there is sufficient data to make informed decisions.

## **Federal Funding Sources**

- Federal formula funds for transit (5307, 5311)
  - 20-30% of YoloTD budget
  - Can only be spent on transit
  - Requires local match
    - Requires 50% match for transit operations
    - Requires 20% match for capital projects
  - One-time COVID recovery funds fall into this category, with some easing of requirements



## **State of California Funding Sources**

CA Transportation Development Act (TDA)

- Approximately half of YoloTD budget
- Serves as local match in Yolo County
- State Transit Assistance (STA)
  - Funded by tax on diesel fuel
  - Can <u>only</u> be used for transit
  - 10-20% of YoloTD budget
- Local Transportation Funds (LTF) are <u>prioritized</u> for transit
  - Funded by general sales tax
  - Can be claimed by jurisdictions for other transportation needs if conditions are met
  - 25-35% of YoloTD budget



## **Claiming LTF for Other Uses**

- SACOG determines which local transportation projects are eligible for LTF funding
- Unmet Transit Needs: LTF can only be used for other purposes if SACOG has determined there are no *"unmet transit needs that are reasonable to meet."*
- Currently, YoloTD uses 48% of available state funds, while 52% are claimed by Yolo County jurisdictions for other needs
  - \$9 million for YoloTD in FY 23/24 budget
  - \$9.2 million for Yolo County jurisdictions



### Item 6: 24/25 Budget and Work planning Process Other Sources of Revenue in YoloTD Budget

- Passenger fares *\$1 million*
- Cache Creek Casino mitigation \$1.2 million
- Fuel sales and renewable energy credits \$350,000
- Causeway Connection *\$500,000*
- Grants for capital and planning projects \$4.5 million



## **New/Emerging Sources of Funding**

- California Budget Act of 2023 (SB 125):
  - Provides \$1.1 billion in new transit operations funding over 4 years
  - Restores \$2 billion in transit capital funds (can be flexed for operations)
  - SACOG to award funds via competitive program
- Yolo 80 Project VMT mitigation plan and future toll revenues
  - Approximately \$3 million annually for YoloTD transit operations and voluntary trip reduction program



## Budget Process (YoloTD By-Laws)

- Mid-March: SACOG issues LTF apportionments
- **By April 30:** YoloTD shares draft budget with local jurisdictions
- **April May:** TAC and CAC meetings on budget
- **May:** YoloTD Board discusses draft budget (informational)
- **By May 30:** Jurisdictions request changes, in writing
- **By June 30:** YoloTD Board approves preliminary or final budget
- **By Aug 30:** YoloTD Board approves final budget



## **Feedback from Member Jurisdictions**

- Concerns about long-term financial forecast and impacts to LTF
   revenue
- City Managers should be more directly engaged in budget process
- Would like to receive draft budget as early as possible



## **Annual Workplan**

- By-laws do not specify annual workplan, but it's a best practice
- Recently, annual workplans were adopted by Board in Oct 2021 and Nov 2022
- Fall 2022 update was postponed to sync up with annual budget process
- FY 24-25 workplan is currently under development

- May 30: City managers share requested changes in writing
- June 10: Board approves workplan and budget (preliminary or final)
- July 8 if needed: Board approves final workplan and budget
